Operation Round Up is a program that allows Capital Electric members to round up their monthly utility bill to the nearest dollar and donate their pennies to a charitable trust. The money accumulates, and an elected board of five co-op members reviews grant applications to determine the best use of those pennies. Over the last 26 years, co-op members have contributed more than \$900,000 to the program, supporting their communities and local nonprofits, and assisting with medical expenses for those in need.

The members serving on the MAC represent the rest of the co-op membership, and they take this role seriously. The co-op has much to be proud of, but also faces issues that are not pleasing nor glamorous, thus requiring discussion. For example, rate increases elicit a considerable number of questions and concerns. We do our best to explain the reasons for the changes, while listening to concerns. Our goal is to leave the meeting with questions answered and a commitment to move forward in a positive and productive manner.

This year's primary topics included communication and engagement with members; rate structure changes and how you can reduce your individual energy costs via available programs; rebuilding the rural distribution system, which includes retirement of aging poles and lines; the near completion of wireless meter change-outs; system reliability and available grants; and details regarding our annual meeting June 11.

New members are joining the MAC regularly, learning about co-op success, as well as challenges we face. Members ask in-depth questions and bring fresh and innovative ideas to the table. Conversations move from supportive to serious, and there are even a few laughs enjoyed by those attending.

Attendees have various reasons for membership,

and they often have different reasons why they feel the way they do about the outcome.

Member Karen DaSilva was pleased with the meeting format and the information provided.

"I appreciated Jeff Holzer's explanation of the equipment being used, and the maintenance required to keep our electricity flowing. It was very interesting to see the aging lines, poles and meters and how they require replacement to operate effectively. I take for granted the lights will fire up when I hit the switch. I now have a true appreciation for the complexity of this task," she says.

While serving on MAC, Blake Hager appreciates what is being done at the co-op.

"The Capital Electric staff is doing a great job and should be proud to work for an amazing organization," he says.

The terms of MAC members are staggered, so they are limited to three years. This method has changed in the past few years, as previous members often served on the committee for many years. We greatly appreciate their service, however, we felt the need to give more members the opportunity to be part of what we aim to accomplish. As our membership grows, so does the number of members interested in being involved.

Board minute excerpts MARCH 27

The regular meeting of the board of directors of Capital Electric Cooperative was held on Wednesday, March 27.

Also present were: Manager Paul Fitterer, Business Manager Luke Steen, Operations Manager Jeff Holzer, Engineering Services Manager Greg Owen, Energy Services Manager Josh Schaffner, Manager of Communications and IT Wes Engbrecht and Attorney Zachary Pelham of Pearce Durick PLLC, who acted as recording secretary.

Financial Review: Prior to the board meeting, the financial review committee reviewed the February check register and expenditures. The financial review was approved as presented.

Management Reports (Business Department, Operations Department, Engineering Services, Energy Services and Communications/IT):

Business Department Report: Steen presented the February financial and statistical report to the board.

Revenue was behind the budgeted amount for February, as \$3,456,891 was generated in comparison with the budgeted figure of \$3,668,848 (unfavorable variance of \$211,957 or 5.8%).

Capital Electric's February load factor of was behind budget by 3.89%.

The operating margin for February was \$107,006, ahead of the budgeted amount of \$-12,118. The total margin for February was \$113,666, which was ahead of the budgeted \$-4,496.

Capital Electric began billing 36 new services in February, bringing our active services to 22,269 versus 21,979 at this time last year, or a net increase of 290 accounts over the last 12 months.

Total cash on hand and accounts receivable balances were reviewed.

Estate Retirements: Following review of the financial condition of the cooperative and recommendation by management, payment of capital credits was approved to five member estates totaling \$3,550.49.

McLean Sheridan Rural Water: The annual rate adjustment as presented for McLean Sheridan Rural Water District was approved.

Western Area Power

Administration Wheeling Rate: The annual rate adjustment as presented for the Garrison Diversion and Conservancy District was approved.

Revenue Deferral: Approval was made to utilize \$891,000 of Capital Electric's revenue deferral fund for the 2023 financial year.

2023 Capital Credit Allocation: The allocation of 2023 capital credits was approved, pending final review by auditors:

Co-op	\$289,505.19

Total **\$3,009,309.74**

Building Addition Rural Utilities Service (RUS) Form 219: The RUS Form 219 Inventory of Work Orders for the building addition was approved.

Operations Report: Holzer reviewed the written report from the operations department. Holzer reported crews have made significant progress on installing the remaining meters with under 100 left to change before May 1, meetings with all departments have been held on Capital Electric's storm response plan, and the new TEREX digger derrick truck was delivered.

Safety Report: No-lost time accidents. Jeff Tweten, safety instructor with the North Dakota Association of Electric Cooperatives (NDAREC), held a safety meeting on March 14 on CPR and first-aid training.

Engineering Services Report: Owen reviewed the written report from engineering services.

Contractor Price Quotes: Contractors and their price quotes were approved as presented.

Energy Services: Schaffner reviewed the energy services report. Seventy-three service orders were completed in February. Schaffner reported on energy services covering the Touchstone Energy® booth at the 2024 Bismarck-Mandan Home Show, continued work to develop video resources explaining the new rate structures and attendance at the annual township officers meeting.

Physical Inventory: The 2024 energy services material inventory adjustments were approved as presented.

Communications and IT: Engbrecht reviewed the communications and

IT report. Engbrecht reported on the upcoming Nominating Committee meeting in April, Operation Round Up awarding 20 grants totaling \$37,000, and the selection of Legacy High School's Jamison Lang as Capital Electric's scholarship recipient for 2024.

Policy III-5 Vacant Services: Owen reviewed revisions to the vacant services policy, which was approved as presented.

Basin Electric Power Cooperative: Fitterer reported on Basin Electric matters.

Central Power Electric Cooperative: Fitterer reported on annual meeting materials. Charles reported on Central Power Electric matters.

Industry Update: Fitterer reviewed materials related to power markets and general cooperative news.

NDAREC: Vilhauer reported updates on NDAREC and Rural Development Finance Corporation grants.

NRECA: Fitterer reported an update on the National Rural Electric Cooperative Association PowerXchange conference. ☺
